Motoring Expenses

The costs of representing a motoring offence will largely depend upon the type of case, whether the case goes to trial and whether a guilty plea is entered into. The following fees represent an average cost for defending the most common traffic offences in the UK: -

i. Speeding

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of £3,500 - £6,250 plus VAT at 20%

ii. Using a mobile phone whilst driving

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of £2,500 - £6,250 plus VAT at 20%.

iii. Drink driving and Drug-impaired driving

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of £5,500 - £9,250 plus VAT at 20%.

iv. Careless and Dangerous driving

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of $\pounds 2,500 - \pounds 6,250$ plus VAT at 20%.

v. Driving whilst disqualified and without License, Insurance or MOT

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of £4,500 - £7,250 plus VAT at 20%.

vi. Failure to comply with a road sign or traffic lights

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of $\pounds 2,500 - \pounds 6,250$ plus VAT at 20%.

vii. Failure to confirm identity of driver

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of $\pounds 2,500 - \pounds 6,250$ plus VAT at 20%.

viii. 'Totting Up' and disqualification, to include all mitigating arguments

If a guilty plea is entered into, the average cost will be in the region of £1,500 - £3,750 plus VAT at 20%.

If the matter proceeds to trial, the average cost will be within the region of £4,500 - £9,250 plus VAT at 20%.

If a guilty plea is entered into for the aforementioned offences, and an Exceptional Hardship Application is made, the average cost will be within the region of £2,500 - £5,250 plus VAT @ 20%.

You will note that our fees do not include VAT. VAT on our fees must therefore be paid in addition to our fees.

No 'disbursements' (payments to third parties') are included within the fee range quoted above. The amount of the disbursements listed below are subject to change at any time depending on factors outside of our control and no warranty is given as to the accuracy of any such amount. The likely disbursements may be: -

- Counsel/Barrister Fee (ranging from £800 £3,000 plus VAT, dependant on seniority and amount of time spent)
- Travel Expenses (ranging from £50 £250 dependant on distance and mode of transport)

- vi. Preparing to attend Court or Instructing Counsel to represent you at Court.
